



IF YOU ARE OFFERED A POSITION THE FOLLOWING REQUIREMENTS MUST BE MET PRIOR TO ORIENTATION

HEALTH REQUIREMENTS

AS MANDATED BY THE RHODE ISLAND DEPARTMENT OF HEALTH, THE FOLLOWING HEALTH INFORMATION IS REQUIRED PRIOR TO EMPLOYMENT:

1. **PROOF OF IMMUNITY TO MEASLES, MUMPS AND RUBELLA.**
Documentation may include dates of vaccinations or a blood titer indicating immunity.
2. **PROOF OF IMMUNITY TO VARICELLA (CHICKEN POX).**
Documentation may include dates of vaccination, a blood titer indicating immunity or a copy of a physician’s record indicating a history of the illness.
3. **DOCUMENTATION (MM/DD/YY) OF TDAP VACCINE.**
If vaccinated more than two years ago, you must obtain a tetanus-diphtheria-pertussis (Tdap) vaccine. Documentation must include mm/dd/yy.
4. **INFLUENZA VACCINE** is required annually (can be obtained at Cedar Crest).
5. **DOCUMENTATION THAT YOU ARE FREE FROM TUBERCULOSIS INFECTION OR DISEASE BY EITHER A NEGATIVE TB TEST OR A NEGATIVE CXR.**
6. **MEDICAL EXAMINATION WITHIN THE PAST 12 MONTHS.**

Hepatitis B and Influenza vaccines are not required for employment but are strongly recommended. Please notify us if you have received either of these vaccines.
